# **SECTION 4. FIRST AID MEASURES**

Inhalation: Call a poison center or doctor if you feel unwell. Effects of exposure (inhalation) to substance may be

delayed. Inhalation of vapors or contact with substance will result in contamination and potential harmful

effects. Move victim to fresh air. Give artificial respiration if victim is not breathing. Administer oxygen if breathing is difficult. Keep victim warm and quiet. ### **SECTION 6. ACCIDENTAL RELEASE MEASURES**

Warn personnel to move away. Prevent entry into sewers, basements or confined areas; dike if needed. Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if without risk. Ventilate the area. Absorb with an

inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material.

Environmental precautions:

Keep away from living quarters. Do not let product enter drains. Prevent further leakage or spillage if safe to do so. Water runoff can cause

environmental damage. Prevent entry into sewers, basements or confined areas; dike if needed.
